YEAR 4 CAMP 2022 – PHILLIP ISLAND ADVENTURE RESORT WEDNESDAY 2ND NOVEMBER TO FRIDAY 4TH NOVEMBER

16nd June, 2022

We are once again offering the opportunity for Year 4 students to attend a 3 day, 2 night camp at Phillip Island Adventure Resort from Wednesday 2nd November (day after Melbourne Cup Day) to Friday 4th November 2022.

As some of you may already know, the camp is an outstanding facility which has provided our students with the chance to take part in some interesting and challenging activities over the last 6 years.

ACCOMMODATION AND ACTIVITIES:

- Accommodation is in rooms of up to 6 students, each room with its own ensuite.
- Some of the activities include: flying fox, crate climb, giant swing and initiative course.
- The children will also visit the Nobbies Boardwalk and A Maze'N Things.



We estimate the cost of this camp to be around **\$340.00**, but it is dependent on the numbers of children participating. To finalise the cost to this camp, we are now asking parents to provide an expression of interest as to whether your child will be attending the camp in 2022, together with a non-refundable \$50.00 deposit. Please do this by completing the attached form, indicating if your child **will or will not** be participating and return it to school by **Friday 15th July 2022**.

Please do not forward cash to school. Payment can be made electronically by logging on to the Sentral Parent Portal and going to the payments section or phoning/visiting the office and paying via EFT. Payment of this deposit will also confirm your child's participation.

Please note: If you are not able to forward the deposit by this date we encourage you to speak with our Business Manager, Tracey Etherington. **We are required to confirm our booking numbers and pricing with the camp facility, and therefore we cannot guarantee children can be accommodated if payment is received after the deposit closing date.**

Upon finalising numbers, we will forward another letter confirming the cost, any Camps, Sports & Excursions Fund credit we are holding for your child, which can help offset the cost of the camp, and offer instalment arrangements. All confirmed participants will be requested to pay the camp in full prior to **Friday 7th October 2022**. We may also require additional parental assistance on the camp. If you are able to assist, please complete the attached form and return it to school. Please note, any parent selected to assist on camp will require a valid Working with Children Check and must be fully (triple) vaccinated. We will contact you at a later date to discuss this.
