INTRODUCTION/LINKS TO CURRICULUM:

As part of the Year 5 History curriculum, this term students will be learning about Australian history and the impacts of convicts and colonisation on development and daily life. To further support this learning, the Year 5s will be visiting The Old Melbourne Gaol. During the visit, students will get the chance to explore the Gaol, and learn about the inmates who were held there and the context of the Gaol in Melbourne's history. Students will also get the opportunity to watch a Courtroom Drama held at the old Magistrates court depicting a mock trial involving Ned Kelly, and enjoy their snack and lunch in the RMIT Alumni courtyard, which adjoins the Old Melbourne Gaol.
